- 5.1Co-option no interest has been expressed. To be placed in the next newsletter and councillors encouraged to ask parishioners.
- 5.2 GDPR no issues to report.
- 5.3 Defibrillator / Bus Shelter Bev updated the meeting, the Runhall Community Group are looking to distribute a survey to ascertain if the parish wish to move these items forward. Once the outcome of the survey is known they will update the parish council.
- 5.4 Proposed new footpath Mike has met with Barnham Broom Parish council chair and is awaiting further communication from them.
- 5.5 Litter wardens no one has come forward for Brandon Parva. Mark Gill along with the Runhall Community Group have organised a litter pick for April 3<sup>rd</sup>. Volunteers asked to meet at Runhall Play area at 2:30pm

- 5.6 Digital/Mobile coverage during power failure. Simon waiting for an update
- 5.7 Annual Parish meeting date agreed as 13<sup>th</sup> April 2022. No outside speaker to be invited. Clerk to send out invites to local groups/organisations as in previous years.
- 5.8 Queen's Platinum Jubilee Celebrations two organisations are holding events in the Parish Welborne village hall jointly with the church on 2<sup>nd</sup> June and Runhall Community Group on 28<sup>th</sup> May. Clerk to apply for South Norfolk's grant to help both events.
- 5.9 Norfolk Lieutenancy Covid commemorative plaques 4 plaques received no responses on locations received. Agreed to approach Welborne village hall to display one and possibly look at displaying others on the notice boards.

#### 6. Planning Matters

- 6.1 Planning History/decisions 2021/22 none presented.
- 6.2 Planning consultation 3PL/2021/1666/F Breckland Council the creation of 651 metre of new channel created on the River Yare, a series of seven wetland scrapes and a series of three ponds. Councillors discussed and agreed to submit the following –

We agree that the re-introduction of a more natural river / wetland is a positive and can bring many long-term benefits.

We have a concern regarding the potential flooding impacts on the properties in our parish, in Coston and Runhall, that sit slightly downstream from the Hambro land covered in this application. The documentation appears contradictory on this point.

The covering letter says

"Flood modelling has also been completed which confirm there is increase in flood risk to property as a result of the project."

The detailed flood report says in 2.4

"This results in some minor flood extent reduction further downstream as a result of the storage provided by the proposed features created as part of the restoration scheme."

We believe that this contradiction should be clarified/corrected. If there is increased risk to properties downstream then we have serious concerns with this project.

Should the project go ahead we believe it would be beneficial if access, such as a public footpath, could be included so that local residents can benefit from the investment.
